  - Mrs. Shirley Graham 45274 Oak Trail
    - Wanted to make sure the Town had on the official record the concerns of the Citizens of Oak Trail:
      - The Filling of dirt on the Higginbotham property across from Cedar River Seafood that backs up to Oak Trail could cause flooding.
      - That the Town is keeping track of the Permits for said property.
      - Mr. Fontes stated that the large retention pond should help with any flooding.
      - Mr. Williams stated that the permits for the pond and filling came through St. John's River Management District. The only permit from the Town was for Land Clearing.
